### **Directions to the Meeting Location**

#### **If driving:**

Enter off of Century Boulevard. Follow the signs to the "Arrival" area of LAX from Century Boulevard. Stay in the left lane while entering LAX. To the left will be an off ramp with a sign that will direct you to the Administration Building and parking. At the bottom of the off ramp is a stop sign (the building that the meeting will be held is directly in front of you). Turn right at the stop sign and go about 50 feet to the parking lot that will then be in front of you after the turn. If the gate is down, push the button and tell the guard that your are there for the meeting in the Board Room.
