Michael Randall Tom, William Wong and Sun Plus Home Pharmacy Services, were requested to appear at the Southern Compliance meeting as the result of an investigation that revealed that William Wong failed to complete a pharmacy self-assessment form, consistently document the IV hood cleaning and refrigerator temperature as required by parenteral pharmacies. In addition Sun Plus Home Pharmacy Services failed to submit the triplicate documents to the Department of Justice at the end of the dispensing month and had stopped performing IV end product testing for contamination.

On August 17, 2001, a violation notice was issued to William Wong and Sun Plus Home Pharmacy Services, for violation of:

- Business and Professions Code section 4301 – Unprofessional conduct.

- California Code of Regulation section 1715 – Self-assessment of a pharmacy by the pharmacist-in-charge.
- California Code of Regulation section 1751.7 – Parenteral therapy – quality assurance.
- Health and Safety Code section 11164 – Prescription for Schedule II, III, IV, and V controlled substances.

On March 6, 2002, a letter of violation was issued to William Wong and Sun Plus Home Pharmacy Services, for violation of:

- Business and Professions Code section 4301 – Unprofessional conduct.
- Code of Federal Regulations 1304.11 – Biennial Inventory.

Mary J. Holtgrave, Cordell Davidson Cross, Ronald E. Landells, and P.J.'s Prescription Shoppe, were requested to appear at the Southern Compliance meeting as the result of an investigation that revealed that a refill was dispensed for generic Vicodin early, and without prescriber authorization. In addition the pharmacy's computer system lacked clarity in identifying the prescription changes in quantity and directions for use.

On September 10, 2001, letters of violation were issued to Mary J. Holtgrave, and P.J.'s Prescription Shoppe, for violation of:

- Business and Professions Code section 4301 – Unprofessional conduct.
- Business and Professions Code section 4301 (j) – Unprofessional conduct, the violation of any statutes of this state or of the United States regulating controlled substances and dangerous drugs.
- Business and Professions Code section 4063 – Refill of prescription for dangerous drugs or device; prescriber authorization.
- California Code of Regulation section 1716 – Variation from prescription.
- California Code of Regulation section 1717 (b) – Pharmaceutical practice, the identity of the dispensing pharmacist.
- California Code of Regulation section 1717 (c) – Pharmaceutical practice, receipt of an orally transmitted prescription, the pharmacist shall reduce it to writing, initial the prescription.
- Code of Federal Regulations 1306.21 – Requirement of prescription.
