This letter is to provide you with important information concerning the recall of a limited number of lots of six IV bag products produced by Leiters Health due to a potency concern.

While we have not received any reports of adverse events or customer complaints associated with this concern, out of an abundance of caution and after consultation with FDA, we are initiating a voluntary recall on a limited number of lots of IV bags with this concern.

## **Corrective Action Taken:**
