

The Board of Pharmacy has received notice of the following product recall. The Board strongly encourages pharmacies to immediately review their quality assurance and recall policies and procedures to determine if any corrective action is required.

This is to inform you of that Glenmark is initiating a recall to the Retail level involving the prescription product Atomoxetine Capsules USP 10mg, 18mg, 25mg, 40mg, 60mg, 80mg, and 100mg.

The recall to the retail level of the above identified product batches for Atomoxetine Capsules USP 10mg, 18mg, 25mg, 40mg, 60mg, 80mg, and 100mg have been initiated out of an abundance of caution due to the presence of a nitrosamine, N-Nitroso Atomoxetine Impurity above the current Acceptable Intake Level in certain batches. To date, Glenmark has not received any reports of adverse events related to this recall.

Nitrosamines are common in water and foods, including cured and grilled meats, dairy products, and vegetables. These impurities may increase the risk of cancer if people are exposed to them above acceptable levels over long periods of time. There is no immediate risk to patients taking this medication and the probability of serious adverse health consequences is remote.
