

The Board of Pharmacy has received notice of the following product recall. The Board strongly encourages pharmacies to immediately review their quality assurance and recall policies and procedures to determine if any corrective action is required.

Teva Pharmaceuticals USA, Inc. (Teva USA) is initiating a nationwide recall of the below twenty-one (21) lots of Metoprolol Succinate Extended-Release Tablets, USP 25 mg, 50 mg, 100 mg and 200 mg to the RETAIL LEVEL. The product in this recall is distributed under the Teva Pharmaceuticals USA, Inc. label. The reason for the recall is out-of-specification (OOS) dissolution result, associated with these specific lots. The main safety concern that may potentially arise from the out-of-specification (OOS) dissolution result may impact drug release and consequent absorption. Extended-release formulations rely on controlled dissolution to maintain therapeutic plasma concentrations over 24 hours. Out-of-specification dissolution results may suggest altered drug release, potentially leading to reduced efficacy and poor disease control. According to the Health Hazard Assessment by Teva USA, exposure to the product of concern could lead to moderate adverse events and the likelihood of the harm was assessed as remote. The overall risk of harm in the patient population is low.

This recall is being made with the knowledge of the U.S. Food and Drug Administration.
