

The Board of Pharmacy has received notice of the following product recall. The Board strongly encourages pharmacies to immediately review their quality assurance and recall policies and procedures to determine if any corrective action is required.

Amneal Pharmaceuticals LLC is initiating a recall of thirty (30) specific batches of Sulfamethoxazole/Trimethoprim Tablets, USP, 800 mg/160 mg and Chlorpromazine Hydrochloride Tablets, USP (25 mg, 50 mg, 100 mg, and 200 mg) associated with a specific lot of auxiliary polyester coil, due to the detection of a micro-organism. **No micro-organism was detected on any tablets from any of the retain sample bottles tested from the 30 batches being recalled.** No market complaint or adverse event has been received for any of the recall specific batches for any microbial related issue. Out of an abundance of caution and commitment to quality Amneal is initiating a recall of the finished product batches that used this lot of polyester coil. This recall is to the Retail level.

Sulfamethoxazole/Trimethoprim Tablets, USP, 800 mg/160 mg is packaged in 100 and 500 count bottles. This recall pertains only to the **800 mg/160 mg strength** and only to the lots listed above. No other Sulfamethoxazole/Trimethoprim Tablets, USP, 800 mg/160 mg batches are impacted.

Chlorpromazine Hydrochloride Tablets, USP is packaged in 100 tablet count bottles. This recall pertains only to the **strengths and lots** listed above. No other Chlorpromazine Hydrochloride Tablets, USP strengths or batches are impacted. The product strengths and batch numbers listed below are included in this recall.
