The following stipulation is agreed to by and resolves the administrative cases pending as to Respondents Advantage Health Care HIV & Compounding Inc., dba Garden Grove Community Pharmacy (Respondent Garden Grove); AHCS Specialty Care, LLC, dba AHCS Specialty Care (Respondent AHCS Specialty Care I); Innovative Healthcare Capital, LLC and AHCS Specialty Care, LLC, dba AHCS Specialty Care (Respondent AHCS Specialty Care II); Advantage Healthcare Services, dba Mission Plaza Pharmacy (Respondent Mission Plaza); AHCS Specialty Care, LLC, (Respondent AHCS Specialty Care III), Advantage Healthcare Services-Mission Inc., dba Mission Plaza Pharmacy 3 (Respondent Mission Plaza 3); Vimal Bhanvadia (Respondent Bhanvadia); and Nevil Prakash Jhaveri (Respondent Jhaveri). These entities and individuals are collectively called Respondents herein. This stipulation does not apply to or alter the

administrative case pending against Respondents Kinjal Ghanshyam Patel, Shital J. Patel, Shekha Dashrath Patel, or Anil Kanwar.

IT IS HEREBY STIPULATED AND AGREED by and between the above-named parties to the above-entitled proceedings that the following matters are true:

PARTIES

- 1. Anne Sodergren (Complainant), Executive Officer of the Board of Pharmacy (Board), Department of Consumer Affairs, brought this action solely in her official capacity and is represented in this matter by Rob Bonta, Attorney General of the State of California, by Desiree I. Kellogg, Deputy Attorney General, and Joshua A. Room, Supervising Deputy Attorney General.
- 2. Respondents Garden Grove, Mission Plaza, Mission Plaza 3 and AHCS Specialty Care III, are acting in this proceeding through Respondent Bhanvadia, an officer, shareholder, or member of those entities, who has been designated and authorized to enter into this agreement for those entities.
- 3. Respondents AHCS Specialty Care I, and AHCS Specialty Care II are acting in this proceeding through Respondents Bhanvadia and Jhaveri, members of those LLCs, who have been designated and authorized to enter into this agreement for those entities.
- Collectively, Respondents are represented in this proceeding by Armond Marcarian,
 Marc L. McCulloch and Kristina N. Markarian of the Marcarian Law Firm, whose address is:
 21650 Oxnard Street, Suite 1980, Woodland Hills, California 91367.
- 5. On or about November 19, 2012, the Board issued Pharmacy Permit Number PHY 51109 to Respondent Garden Grove, with Respondent Bhanvadia President and 20% shareholder of Advantage Health Care HIV & Compounding, Inc. and Respondent Shekha Dashrath Patel VP and 20% shareholder of Advantage Health Care HIV & Compounding, Inc. The Pharmacy Permit was in full force and effect at all times relevant to the charges brought in the First Amended Accusation and expired on December 1, 2020. It was cancelled on March 8, 2022.
- 6. On or about August 13, 2013, the Board issued Pharmacy Permit Number PHY 51550 to Respondent Mission Plaza, with Respondent Bhanvadia President and 17% shareholder of Advantage Healthcare Services, Respondent Shekha Dashrath Patel 16% shareholder of

Advantage Healthcare Services, and Respondent Kinjal Ghanshyam Patel 16% shareholder of Advantage Healthcare Services. The Pharmacy Permit was in full force and effect at all times relevant to the First Amended Accusation and was cancelled on March 8, 2022.

- 7. On or about December 19, 2017, the Board issued Pharmacy Permit Number PHY 55932 to Respondent AHCS Specialty Care I. Respondents Jhaveri, Bhanvadia, Shekha Dashrath Patel, and Kinjal Ghanshyam Patel, were identified as members of AHCS Specialty Care, LLC. The Pharmacy Permit was in full force and effect at all ties relevant to the charges in the First Amended Accusation and Accusation and was cancelled on December 3, 2020.
- 8. On or about December 1, 2020, the Board issued Pharmacy Permit Number PHY 58059 to Respondent AHCS Specialty Care II. Respondent Jhaveri was identified as a member. The Pharmacy Permit was in full force and effect at all times relevant to the charges in the Accusation and was canceled on November 9, 2023.
- 9. On or about January 22, 2021, the Board received an application for a pharmacy permit from Respondent Mission Plaza 3, with Respondent Bhanvadia as 15% shareholder and officer, and Respondent Shekha Dashrath Patel as 14% shareholder and director. On or about October 8 and 13, 2020, Respondent Bhanvadia and Respondent Shekha Dashrath Patel certified under penalty of perjury the truthfulness of all statements, answers, and representations in the application. On or about September 30, 2021, the Board denied the application.
- 10. On or about February 16, 2021, the Board received an application for a pharmacy permit from Respondent AHCS Specialty Care III, with Respondent Bhanvadia as manager. On or about October 23, 2020, Respondent Bhanvadia certified under penalty of perjury the truthfulness of all statements, answers, and representations in the application. On or about September 30, 2021, the Board denied the application.

JURISDICTION

11. First Amended Accusation Nos. 7223, 7538 and 7539 were filed before the Board, and are currently pending against Respondents Garden Grove, AHCS Specialty Care I, and Mission Plaza. First Amended Statement of Issues No. 7210 was filed before the Board and is currently pending against Respondent AHCS Specialty Care III. First Amended Statement of

Issues No. 7211 was filed before the Board and is currently pending against Respondent Mission Plaza 3. Accusation No. 7618 was filed before the Board and is currently pending against Respondents AHCS Specialty Care I and AHCS Specialty Care II.

12. First Amended Accusation Nos. 7223, 7538 and 7539, First Amended Statement of Issues No. 7210, First Amended Statement of Issues No. 7211, and Accusation No. 7618, and all other statutorily required documents, were properly served on Respondents. Respondents timely filed Notices of Defense or requests for hearing. First Amended Accusation Nos. 7223, 7538 and 7539, First Amended Statement of Issues No. 7210, and First Amended Statement of Issues No. 7211, are attached as Exhibit A and incorporated by reference. Accusation No. 7618 is attached as Exhibit B and incorporated by reference.

ADVISEMENT AND WAIVERS

- 13. Respondents have carefully read, fully discussed with counsel, and understand the charges and allegations in First Amended Accusation Nos. 7223, 7538 and 7539, First Amended Statement of Issues No. 7210, First Amended Statement of Issues No. 7211, and Accusation No. 7618. Respondents have also carefully read, fully discussed with counsel, and understand this Stipulated Surrender of Licenses, Affirmance of Denials, and Disciplinary Order.
- 14. Respondents are fully aware of their legal rights in this matter, including the right to a hearing on charges and allegations in the First Amended Accusation, both of the two First Amended Statements of Issues, and the Accusation; the right to confront and cross-examine the witnesses against them; the right to present evidence and to testify on their own behalf; the right to the issuance of subpoenas to compel the attendance of witnesses and the production of documents; the right to reconsideration and court review of an adverse decision; and all other rights accorded by the California Administrative Procedure Act and other applicable laws.
- 15. Respondents hereby voluntarily, knowingly, and intelligently waives and gives up each and every right set forth above.

CULPABILITY

16. Respondents Garden Grove, AHCS Specialty Care I, and Mission Plaza, hereby understand and agree that the charges in First Amended Accusation Nos. 7223, 7538 and 7539, if

proven at a hearing, constitute cause for imposing discipline on their respective Pharmacy Permits. Respondents AHCS Specialty Care I and AHCS Specialty Care II hereby understand and agree that the charges in Accusation No. 7618, if proven at a hearing, constitute cause for imposing discipline on their respective Pharmacy Permits.

- 17. Respondents AHCS Specialty Care III and Mission Plaza 3 hereby understand and agree that the charges in First Amended Statement of Issues No. 7210 and/or First Amended Statement of Issues No. 7211, if proven at a hearing, constitute cause for denial of their applications for Pharmacy Permits.
- 18. For the purpose of resolving these cases without the expense and uncertainty of further proceedings, Respondents hereby agree that, at a hearing, Complainant could establish a factual basis for the charges in First Amended Accusation Nos. 7223, 7538 and 7539, First Amended Statement of Issues No. 7210, First Amended Statement of Issues No. 7211, and Accusation No. 7618, that those charges constitute cause for discipline or denial, and that Respondents hereby give up their right to contest those charges.
- 19. Respondents understand that by signing this stipulation they enable the Board to issue an order accepting the surrender of their Pharmacy Permits and affirming prior denials of their applications for further or additional licenses, without further process.

CONTINGENCY

20. This stipulation shall be subject to approval by the Board. Respondents understand and agree that counsel for Complainant and staff of the Board may communicate directly with the Board regarding this stipulation and settlement, without notice to or participation by Respondents or their counsel. By signing the stipulation, Respondents understand and agree that they may not withdraw their agreement or seek to rescind the stipulation prior to the time the Board considers and acts upon it. If the Board fails to adopt this Stipulated Surrender of Licenses, Affirmance of Denials, and Disciplinary Order as its Decision and Order, it shall be of no force or effect, except for this paragraph, it shall be inadmissible in any legal action between the parties, and the Board shall not be disqualified from further action by having considered this matter.

- 21. The parties understand and agree that Portable Document Format (PDF) and facsimile copies of this Stipulated Surrender of Licenses, Affirmance of Denials, and Disciplinary Order, including PDF and facsimile signatures thereto, shall have the same force and effect as originals.
- 22. This Stipulated Surrender of Licenses, Affirmance of Denials, and Disciplinary Order is intended by the parties to be an integrated writing representing the complete, final, and exclusive embodiment of their agreement. It supersedes any and all prior or contemporaneous agreements, understandings, discussions, negotiations, and commitments (written or oral). This Stipulated Surrender of Licenses, Affirmance of Denials, and Disciplinary Order may not be altered, amended, modified, supplemented, or otherwise changed except by a writing executed by an authorized representative of each of the parties.
- 23. In consideration of the foregoing admissions and stipulations, the parties agree that the Board may, without further notice or formal proceeding, issue and enter the following Order:

DISCIPLINARY ORDER

IT IS HEREBY ORDERED that (1) Pharmacy License No. PHY 51109, issued to Respondent Advantage Health Care HIV & Compounding Inc., dba Garden Grove Community Pharmacy; (2) Pharmacy License No. PHY 51550, issued to Advantage Healthcare Services, dba Mission Plaza Pharmacy; (3) Pharmacy License No. PHY 55932, issued to AHCS Specialty Care, LLC, dba AHCS Specialty Care; and (4) Pharmacy License No. PHY 58059, issued to Innovative Healthcare Capital, LLC and AHCS Specialty Care, LLC, dba AHCS Specialty Care, are hereby surrendered and accepted by the Board. Those Respondents shall relinquish remaining premises wall licenses and renewal licenses within ten (10) days of the effective date of this decision.

1. The surrender of Pharmacy Permits by Respondents Garden Grove, Mission Plaza, AHCS Specialty Care I, and AHCS Specialty Care II, and the acceptance of the surrendered licenses by the Board, shall constitute the imposition of discipline against these Respondents. This decision constitutes a record of discipline and shall become part of each Respondent's license history with the Board. Respondents understand and agree that for purposes of Business and Professions Code section 4307, these surrenders shall be treated like revocations.

- 2. Respondents Garden Grove, Mission Plaza, AHCS Specialty Care I, and AHCS Specialty Care II, shall lose all rights and privileges as pharmacies in California as of the effective date of the Board's decision and order.
- 3. Respondents Garden Grove, Mission Plaza, AHCS Specialty Care I, and AHCS Specialty Care II, and their respective managers, administrators, owners, members, officers, directors, associates, partners, and any other person with management or control of these entities, are jointly and severally liable for costs of investigation and prosecution of \$40,000.00 incurred as to First Amended Accusation Case Nos. 7223, 7538, 7539 and Accusation Case No. 7618.
- 4. Respondents Garden Grove, Mission Plaza, AHCS Specialty Care I, and AHCS Specialty Care II, and any of their respective managers, administrators, owners, members, officers, directors, associates, partners, or any other person with management or control of these entities, may only seek a new or reinstated license from the Board by a new application for licensure. These entities and persons shall not be eligible to petition for reinstatement.
- 5. Respondents Garden Grove, Mission Plaza, AHCS Specialty Care I, and AHCS Specialty Care II, and any of their respective managers, administrators, owners, members, officers, directors, associates, partners, or any other person with management or control of these entities, may not reapply for any license from the Board for three (3) years from the effective date of this decision. All of these entities and persons hereby stipulate that should they apply for any license from the Board on or after the effective date of this decision, all allegations set forth in First Amended Accusation Nos. 7223, 7538 and 7539 and Accusation No. 7618 shall be deemed to be true, correct and admitted by these entities or persons when the Board determines whether to grant or deny any such application. Any such applicant shall satisfy all requirements applicable to any license applied for as of the date the application is submitted to the Board. Any such applicant shall be required to report these surrenders as prior disciplinary action.
- 6. Respondents Garden Grove, Mission Plaza, AHCS Specialty Care I, and AHCS Specialty Care II, and their respective managers, administrators, owners, members, officers, directors, associates, partners, or any other person with management or control of these entities, stipulate that before any of these persons or entities may apply for any license from the Board on

PARTIES

- 1. Anne Sodergren (Complainant) brings the First Amended Accusation and First Amended Statements of Issues solely in her official capacity as the Executive Officer of the Board of Pharmacy, Department of Consumer Affairs (Board).
- 2. On or about November 19, 2012, the Board issued Pharmacy Permit Number PHY 51109 to Respondent Advantage Health Care HIV & Compounding Inc., dba Garden Grove Community Pharmacy, and identified Respondent Vimal Bhanvadia as the president and twenty percent shareholder of Advantage Health Care HIV & Compounding, Inc. and Respondent Shekha Dashrath Patel as the Vice-President, Pharmacist-in-Charge and twenty percent shareholder of Respondent Advantage Health Care HIV & Compounding, Inc. (Respondent Garden Grove Community Pharmacy). The Pharmacy Permit was in full force and effect at all times relevant to the charges brought herein and expired on December 1, 2020. It was cancelled on March 8, 2022.
- 3. On or about August 13, 2013, the Board issued Pharmacy Permit Number PHY 51550 to Respondent Advantage Health Care Services, doing business as Mission Plaza Pharmacy and identified Respondent Vimal Bhanvadia as the president and seventeen percent shareholder of Advantage Health Care Services, Respondent Shekha Dashrath Patel as the sixteen percent shareholder of Advantage Health Care Services and Respondent Kinjal Ghanshyam Patel as the Pharmacist-in-Charge and sixteen percent shareholder of Advantage Health Care Services (Mission Plaza Pharmacy). The Pharmacy Permit was in full force and effect at all times relevant to the charges brought herein and was cancelled on March 8, 2022.
- 4. On or about December 19, 2017, the Board issued Pharmacy Permit Number PHY 55932 to Respondent AHCS Specialty Care, LLC and Innovative Healthcare Capital, LLC, doing business as AHCS Specialty Care and identified Respondent Vimal Bhanvadia as a member and forty-three percent shareholder of AHCS Specialty Care, LLC, and Innovative Healthcare Capital, LLC, Respondent Shekha Dashrath Patel as a member and seven percent shareholder of AHCS Specialty Care, LLC and Innovative Healthcare Capital, LLC, Respondent Kinjal Ghanshyam Patel as a member and seven percent shareholder of AHCS Specialty Care, LLC and

Innovative Healthcare Capital, LLC and Shital J. Patel as the Pharmacist-in-Charge of AHCS Specialty Care (AHCS Specialty Care). The Pharmacy Permit was in full force and effect at all times relevant to the charges brought herein, expired on December 1, 2020 and was cancelled on December 3, 2020.

- 5. On or about October 10, 2007, the Board of Pharmacy issued Pharmacist License Number RPH 60337 to Respondent Shekha Dashrath Patel. The Pharmacist License was in full force and effect at all times relevant to the charges brought herein and will expire on September 30, 2023, unless renewed.
- 6. On or about August 6, 2008, the Board of Pharmacy issued Pharmacist License Number RPH 61294 to Respondent Kinjal Ghanshyam Patel. The Pharmacist License was in full force and effect at all times relevant to the charges brought herein and will expire on August 30, 2024, unless renewed.
- 7. On or about June 29, 1998, the Board of Pharmacy issued Pharmacist License Number RPH 50125 to Respondent Shital J. Patel. The Pharmacist License was in full force and effect at all times relevant to the charges brought herein and will expire on December 31, 2023, unless renewed.
- 8. On or about January 22, 2021, the Board received an application for a pharmacy permit from Respondent Advantage Health Care Services-Mission, Inc., dba Mission Plaza Pharmacy 3 with Respondent Vimal Bhanvadia identified as a fifteen percent shareholder and officer and Respondent Shekha Dashrath Patel identified as a fourteen percent shareholder and director. On or about October 8 and 13, 2020, Respondent Shekha Dashrath Patel and Respondent Vimal Bhanvadia certified under penalty of perjury to the truthfulness of all statements, answers, and representations in the application. On or about September 30, 2021, the Board denied Respondent Advantage Health Care Services-Mission, Inc.'s application.
- 9. On or about February 16, 2021, the Board received an application for a pharmacy permit from Respondent AHCS Specialty Care, LLC, with Respondent Vimal Bhanvadia identified as a manager of AHCS Specialty Care, LLC. On or about October 23, 2020, Respondent Vimal Bhanvadia certified under penalty of perjury to the truthfulness of all

statements, answers, and representations in the application. On or about September 30, 2021, the Board denied Respondent AHCS Specialty Care, LLC's application.

JURISDICTION

- 10. The First Amended Accusation and First Amended Statements of Issues are brought before the Board under the authority of the following laws. All section references are to the Business and Professions Code (Code) unless otherwise indicated.
- 11. Code section 4011 provides that the Board shall administer and enforce both the Pharmacy Law (Bus. & Prof. Code, § 4000 et seq.) and the Uniform Controlled Substances Act (Health & Safety Code, § 11000 et seq.).
- 12. Code section 4300, subdivision (a) provides that every license issued by the Board may be suspended or revoked.
 - 13. Code section 4300, subdivision (c) states:

The board may refuse a license to any applicant guilty of unprofessional conduct. The board may, in its sole discretion, issue a probationary license to any applicant for a license who is guilty of unprofessional conduct and who has met all other requirements for licensure. . .

14. Code section 4300.1 states:

The expiration, cancellation, forfeiture, or suspension of a board-issued license by operation of law or by order or decision of the board or a court of law, the placement of a license on a retired status, or the voluntary surrender of a license by a licensee shall not deprive the board of jurisdiction to commence or proceed with any investigation of, or action or disciplinary proceeding against, the licensee or to render a decision suspending or revoking the license.

15. Code section 4307, subdivision (a) states:

Any person who has been denied a license or whose license has been revoked or is under suspension, or who has failed to renew his or her license while it was under suspension, or who has been a manager, administrator, owner member, officer, director, associate, or partner of any partnership, corporation, firm, or association whose application for a license has been denied or revoked, is under suspension or has been placed on probation, and while acting as the manger, administrator, owner, member, officer, director, associate, or partner had knowledge or knowingly participated in any conduct for which the license was denied, revoked, suspended, or placed on probation, shall be prohibited from serving as a manger, administrator, owner, member, officer, director, associate, or partner of a licensee as follows:

(1) Where a probationary license is issued or where an existing license is placed on probation, this prohibition shall remain in effect for a period not to exceed five years.

(2) Where the license is denied or revoked, the prohibition shall continue until the license is issued or reinstated.

INTRODUCTION

- 16. This case is about the purchasing of adulterated drugs from suspicious entities or persons and the dispensing of them which violates both federal and state law. Namely, such actions violate state Pharmacy Law (*i.e.*, Business & Professions Code section 4169, subdivision (a)), state drug laws (*i.e.*, Health & Safety Code section 111295), and federal law ([Drug Supply Chain Security Act], *i.e.*, 21 U.S.C. § 331, subd. (t), 21 U.S.C. § 360eee-1, subds. (a), (d)(1)(A)(i), (d)(3) and (d)(4)(i)).
- 17. Respondents failed to exercise due diligence when purchasing expensive HIV drugs vulnerable to diversion and counterfeiting from entities or individuals posing as the legitimate wholesalers or out of state distributors, Premier Rx Wholesale, LLC and PI Services, LLC. Respondents ignored several red flags when purchasing these drugs from the persons or entities posing as Premier Rx Wholesale, LLC and faux PI Services, LLC which include the fact that they were not distributors authorized by the manufacturers to distribute their drugs, the addresses and other contact information for the faux Premier Rx Wholesale, LLC and faux PI Supply Services, LLC did not match the addresses and other contact information listed on the Board's website for the legitimate wholesalers doing business with those same names, the drugs listed on the packing lists enclosed with the drugs were different than the drugs listed on the invoices, many of the drugs purchased from the faux Premier Rx Wholesale, LLC and faux PI Supply Services, LLC were heavily discounted, not all the drugs purchased from the faux Premier Rx Wholesale, LLC and faux PI Supply Services, LLC were received by Respondents, and the pedigrees received from faux Premier Rx Wholesale, LLC and faux PI Supply Services or questionable.
- 18. Drugs entering the drug supply chain through illegitimate means, can pose a threat to public safety, particularly if they are counterfeit, stolen or contaminated. Indeed, Respondent Garden Grove Community Pharmacy purchased a drug, Biktarvy, which contained rocks inside its sealed bottle from the faux Premier Rx Wholesale, LLC and dispensed that drug (*i.e.*, the

1	rocks) to a patient. Respondents' actions compromised the integrity of the drug supply chain and	
2	potentially harmed fragile and vulnerable patients relying on the efficacy of drugs used to treat	
3	AIDS and HIV.

Unprofessional conduct for a pharmacist may include any of the following:

Acts or omissions that involve, in whole or in part, the inappropriate exercise of his or her education, training, or experience as a pharmacist, whether or not the act or omission arises in the course of the practice of pharmacy or the ownership, management, administration, or operation of a pharmacy or other entity licensed by the board.

29. Health and Safety Code section 111250 states:

Any drug or device is adulterated if it consists, in whole or in part, of any filthy, putrid, or decomposed substance.

30. Health and Safety Code section 111255 states:

Any drug or device is adulterated if it has been produced, prepared, packed, or held under conditions whereby it may have been contaminated with filth, or whereby it may have been rendered injurious to health.

31. Health and Safety Code section 111295 states:

It is unlawful for any person to manufacture, sell, deliver, hold or offer for sale any drug or device that is adulterated.

32. 21 U.S.C. § 331, subdivision (t) [Food, Drug & Cosmetic Act] states:

The following acts and the causing thereof are prohibited:

The importation of a drug in violation of section 381(d)(1) of this title, the sale, purchase, or trade of a drug or drug sample or the offer to sell, purchase, or trade a drug or drug sample in violation of section 353(c) of this title, the sale, purchase, or trade of a coupon, the offer to sell, purchase, or trade such a coupon, or the counterfeiting of such a coupon in violation of section 353(c)(2) of this title, the distribution of a drug sample in violation of section 353(d) of this title or the failure to otherwise comply with the requirements of section 353(d) of this title, the distribution of drugs in violation of section 353(e) of this title, failure to comply with the requirements under section 360eee-1 of this title, the failure to comply with the requirements under section 360eee-3 of this title, as applicable, or the failure to otherwise comply with the requirements of section 353(e) of this title.

COST RECOVERY

35. DRUGS

- 39. <u>Genvoya</u> is an expensive drug used to treat HIV and a dangerous drug as defined by Business and Professions Code section 4022. Because of its high dollar value, it often is the subject of diversion and counterfeiting efforts.

- 40. <u>Truvada</u> is an expensive drug used to treat HIV and a dangerous drug as defined by Business and Professions Code section 4022. Because of its high dollar value, it often is the subject of diversion and counterfeiting efforts.
- 41. <u>Triumeq</u> is an expensive drug used to treat HIV and is a dangerous drug as defined by Business and Professions Code section 4022. Because of its high dollar value, it often is the subject of diversion and counterfeiting efforts.

FACTUAL ALLEGATIONS

- 42. Respondents Garden Grove Community Pharmacy, AHCS Specialty Care and Mission Plaza Pharmacy were open door, retail community pharmacies located in Garden Grove or Mission Viejo, California, until their licenses were cancelled. They dispensed high value medications administered for the treatment of human immunodeficiency virus infection and acquired immune deficiency syndrome (HIV) to patients throughout California.
- 43. Respondent Garden Grove Community Pharmacy's Pharmacist-in-Charge was Respondent Shekha Patel. She and Respondent Vimal Bhanvadia were shareholders or officers of the corporation that owned Respondent Garden Grove Community Pharmacy. Respondent Vimal Bhanvadia managed finances and created accounts with wholesalers for Respondent Garden Grove Community Pharmacy
- 44. Respondent Mission Plaza Pharmacy's Pharmacist-in-Charge was Respondent Kinjal Patel. He, Respondent Shekha Patel, and Respondent Vimal Bhanvadia were shareholders of the corporation that owned Respondent Mission Plaza Pharmacy.
- 45. Respondent AHCS Specialty Care's Pharmacist-in-Charge was Respondent Shital Patel. Respondent Shekha Patel and Respondent Vimal Bhanvadia were members of the limited liability companies that owned AHCS Specialty Care.
- 46. Premier Rx Wholesale, LLC was a legitimate wholesaler which held an out of state distributor license with the Board. Respondents Garden Grove Community Pharmacy, AHCS Specialty Care and Mission Plaza Pharmacy did not purchase drugs from this legitimate, licensed wholesaler. Rather, Respondents purchased drugs from individuals or entities posing as the legitimate wholesaler, Premier Rx Wholesale, LLC (faux Premier Rx Wholesale, LLC).

47. PI Services, LLC was a legitimate wholesaler, which held an out of state distributor license with the Board. Respondents Garden Grove Community Pharmacy, AHCS Specialty Care and Mission Plaza Pharmacy did not purchase drugs from this legitimate, licensed wholesaler. Rather, Respondents purchased drugs from individuals or entities posing as the legitimate wholesaler, PI Services, LLC (faux PI Services, LLC).

Respondent Garden Grove Community Pharmacy Drug Purchases:

- 48. Respondent Garden Grove Community Pharmacy claimed to have "extensive protocols in place to verify [its] secondary wholesalers, including verification on the BOP website, which is conducted quarterly to ensure that the drug products we purchase are unadulterated."
- 49. Yet, on or about March 8, 2019, Respondent Garden Grove Community Pharmacy did not require faux Premier Rx Wholesale, LLC to submit an application, nor did Garden Grove Community Pharmacy verify all of the information listed for faux Premier Rx Wholesale, LLC on the Board's website, and on the out of state distributor license, including confirming the physical address, telephone number and email address for faux Premier Rx Wholesale, LLC and resolving any discrepancies between the information provided by faux Premier Rx Wholesale, LLC and the information on the Board's website and the out of state distributor license.
- 50. Similarly, Respondent Garden Grove Community Pharmacy did not verify all of the information listed for faux PI Services, LLC on the Board's website, and the out of state distributor license, including confirming the physical address, telephone number and email address for faux PI Services, LLC and resolving any discrepancies between the information provided by faux PI Services, LLC and the information on the Board's website and the out of state distributor's license.
- 51. From March 22, 2019 to May 26, 2020, Respondent Garden Grove Community Pharmacy purchased 9,170 medication packages of the HIV drugs, Genvoya, Biktarvy, Truvada, Triumeq and other medication packages from faux Premier Rx Wholesale, LLC. These purchases comprised almost half of Garden Grove Community Pharmacy's HIV drug inventory. Almost all of these drugs were dispensed to patients.

- 52. From February 18, 2020 to May 28, 2020, Respondent Garden Grove Community Pharmacy purchased 1921 medication packages of the HIV drugs including Atripla, Biktarvy and Descovy from faux PI Services, LLC. All of these drugs were dispensed to patients.
- 53. Respondent Garden Grove Community Pharmacy purchased a drug, Biktarvy, which contained rocks inside a sealed bottle from faux Premier Rx Wholesale, LLC and dispensed it to a patient.
- 54. Respondent Garden Grove Community Pharmacy ignored the following circumstances which increased the likelihood that it was purchasing suspect drug products from faux Premier Rx Wholesale, LLC and faux PI Services, LLC. These circumstances included: (1) Respondent Garden Grove Community Pharmacy purchased from sources which were new to it; (2) Respondent Garden Grove Community Pharmacy purchased high dollar value HIV drugs that have a history of being counterfeited or diverted; (3) Faux Premier Rx Wholesale, LLC and faux PI Supply Services, LLC were not distributors authorized by manufacturers to distribute its HIV drugs; (4) the addresses and other contact information for faux Premier Rx Wholesale LLC and faux PI Supply Services, LLC did not match the addresses and other contact information listed on the Board's website and the out of state distributor licenses; (5) the drugs listed on the packing lists enclosed with the drugs were different than the drugs listed on the invoices; (6) many of the drugs purchased from faux Premier Rx Wholesale, LLC and faux PI Supply Services, LLC were heavily discounted; (7) Respondent Garden Grove Community Pharmacy did not receive all drugs purchased from faux Premier Rx Wholesale, LLC and faux PI Supply Services, LLC; and (8) the pedigrees received from faux Premier Rx Wholesale, LLC and faux PI Services, LLC appeared to be incomplete or questionable.
- 55. Respondent Garden Grove Community Pharmacy paid \$19,531,015.26 to faux Premier Rx Wholesale, LLC. Respondent Garden Grove Community Pharmacy paid for these purchases via checks signed by Respondent Vimal Bhanvadia or Respondent Shekha Patel. Respondent Garden Grove Community Pharmacy also paid faux Premier Rx Wholesale, LLC for drugs never shipped or received by Respondent Garden Grove Community Pharmacy.

- 56. Respondent Garden Grove Community Pharmacy paid \$4,165,233.00 to faux PI Services, LLC. Respondent Garden Grove Community Pharmacy paid for these purchases via checks signed by Respondent Vimal Bhanvadia. Respondent Garden Grove Community Pharmacy also paid faux PI Services, LLC for drugs never shipped or received by Respondent Garden Grove Community Pharmacy.
- 57. Respondent Garden Grove Community Pharmacy received invoices and pedigrees¹ for these drugs from faux Premier Rx Wholesale, LLC and faux PI Services, LLC. The invoices and pedigrees listed a different physical and email address for faux Premier Rx Wholesale, LLC and faux PI Services, LLC, than were listed on the Board's website and the out of state distributor licenses. Additionally, the invoices listed a telephone number for another entity, Wealth Transfer Services Credit Repair in Florida, as the telephone number for faux Premier Rx Wholesale, LLC.
- 58. On December 9, 2019, Respondent Garden Grove Community Pharmacy asked faux Premier Rx Wholesale, LLC to confirm its physical address because the address for the legitimate Premier Rx Wholesale, LLC listed on the Board's website was different than the address listed on the faux Premier Rx Wholesale, LLC invoices. Faux Premier Rx Wholesale LLC did not provide an explanation for the discrepancy and instead, merely re-sent a copy of the legitimate Premier Rx Wholesale, LLC's license. Despite those discrepancies, Respondent Garden Grove Community Pharmacy continued to purchase drugs from faux Premier Rx Wholesale, LLC.
- 59. On May 27, 2020, the manufacturer of a HIV medication drug, Biktarvy, informed Respondent Garden Grove Community Pharmacy that it may have purchased counterfeit or diverted drugs from an unauthorized distributor, faux Premier Rx Wholesale, LLC and requested that Respondent Garden Grove Community Pharmacy quarantine bottles of Biktarvy purchased from faux Premier Rx Wholesale, LLC.
- 60. In June 2020, Respondent Garden Grove Community Pharmacy continued to purchase drugs from faux Premier Rx Wholesale, LLC and expressed its desire to "reengage" with faux Premier Rx, Wholesale LLC to purchase more drugs. After receiving notice that the

¹ A drug pedigree is a statement of origin that identifies each prior sale, purchase, or trade of a drug, including the date of those transactions and the names and addresses of all parties.

Board was investigating Respondent Garden Grove Community Pharmacy for its dispensing of the bottle of Biktary which contained rocks, Respondent Garden Grove Community Pharmacy finally informed faux Premier Rx Wholesale, LLC that it would no longer purchase drugs from faux Premier Rx Wholesale, LLC, noting "there are concerns around product integrity with Premier's supply chain. As previously discussed, patient safety is our number one priority and therefore we will be suspending purchases from Premier until further notice. Our primary responsibility is to mitigate any risk to our patients and ensure compliance with BOP regulations."

- 61. On July 15, 2020, the Board issued a notice of non-compliance with Pharmacy Law to Respondent Garden Grove Community Pharmacy for purchasing drugs from an unlicensed wholesaler, faux Premier Rx Wholesale, LLC.
- 62. On July 20, 2020, Respondent Garden Grove Community Pharmacy augmented its procedures for purchasing drugs from secondary wholesalers, to include a requirement to quarantine drugs purchased from wholesalers whose address on invoices and pedigrees did not match the addresses on their license and the Board's website.
- 63. On September 3, 2020, the manufacturer of Biktarvy notified Respondent Garden Grove Community Pharmacy that its investigation into the potentially counterfeit or diverted drugs sold by faux Premier Rx Wholesale, LLC was on-going. The manufacturer advised Respondent Garden Grove Community Pharmacy that drugs sold by faux Premier Rx Wholesale, LLC were "sourced from non-[manufacturer] authorized distributors which increases the risks that these bottles are suspect or illegitimate. If you chose to dispense the [potentially counterfeit or diverted drugs], be aware of the serious risks, both to patients' health and to Garden Grove's ability to operate as a pharmacy, associated with selling counterfeit medications."
- 64. Despite knowing it had purchased a drug, Biktarvy, containing rocks, Respondent Garden Grove Community Pharmacy continued to dispense drugs purchased from faux Premier Rx Wholesale, LLC to patients until December 30, 2020.

Respondent Mission Plaza Pharmacy Drug Purchases:

- 65. Respondent Mission Plaza Pharmacy had a policy for verifying products received against the purchase records and verifying the pedigree and invoice information.
- 66. Yet, Respondent Mission Plaza Pharmacy did not verify all of the information listed for faux Premier Rx Wholesale, LLC and faux PI Services, LLC on the Board's website and the out of state distributor licenses, including confirming the physical address, telephone number and email address for faux Premier Rx Wholesale, LLC and faux PI Services, LLC, and resolving any discrepancies between the information provided by faux Premier Rx Wholesale, LLC, and faux PI Services, LLC, and resolving any discrepancies between the information provided by faux Premier Rx Wholesale, LLC, and faux PI Services, LLC and the information on the Board's website and the out of state licenses.

- 69. Respondent Mission Plaza Pharmacy paid \$5,615,862.80 for the purchase of drugs to faux Premier Rx Wholesale, LLC and it paid \$2,254,545.00 for the purchase of drugs to faux PI Services, LLC. Respondent Mission Plaza Pharmacy paid for many of these purchases via checks signed by Respondent Kinjal Patel. Respondent Mission Plaza also paid faux Premier Rx Wholesale, LLC and faux PI Services, LLC for drugs never shipped or received by Respondent Mission Plaza Pharmacy.
- 70. Respondent Mission Plaza Pharmacy received invoices and pedigrees for these drugs from faux Premier Rx Wholesale, LLC and PI Services, LLC. The invoices and pedigrees listed a different physical and email address for faux Premier Rx Wholesale LLC and faux PI Services, LLC, than were listed on the Board's website and the out of state distributor's licenses.

71. Respondent Mission Plaza Pharmacy ignored the following circumstances which increased the likelihood that it was purchasing suspect drug products from faux Premier Rx Wholesale, LLC and faux PI Services, LLC. - 74. From May 9, 2019 to May 26, 2020, Respondent AHCS Specialty Care purchased 3,311 medication packages of HIV drugs from faux Premier Rx Wholesale, LLC. All of those drugs were dispensed to patients.
- 75. From February 18, 2020 to May 28, 2020, Respondent AHCS Specialty Care purchased 318 medication packages of HIV drugs from faux PI Services, LLC. All of those drugs were dispensed to patients.
- 76. Respondent AHCS Specialty Care paid \$5,854,547.39 for the purchase of drugs to faux Premier Rx Wholesale, LLC. It paid \$560,323.00 for the purchase of drugs to faux PI Services, LLC. Respondent AHCS Specialty Care paid for these purchases via checks signed by Respondent Vimal Bhanvadia. Respondent AHCS Specialty Care also paid faux Premier Rx Wholesale, LLC and faux PI Services, LLC for drugs never shipped or received by Respondent AHCS Specialty Care.
- 77. Respondent AHCS Specialty Care received invoices and pedigrees for these drugs from faux Premier Rx Wholesale, LLC and faux PI Services, LLC. The invoices and pedigrees listed a different physical and email address for faux Premier Rx Wholesale, LLC and faux PI Services, LLC, than were listed on the Board's website and the out of state distributor's licenses.
- 78. Respondent AHCS Specialty Care ignored the following circumstances which increased the likelihood that it was purchasing suspect drug products from faux Premier Rx Wholesale, LLC and faux PI Services, LLC. Neither Respondents Garden Grove Community Pharmacy, AHCS Specialty Care nor Mission Plaza Pharmacy quarantined all of the drugs purchased from faux Premier Rx Wholesale, LLC and faux PI Services, LLC nor did they promptly investigate their purchases to determine if the drug products were adulterated or otherwise an illegitimate product.

FIRST CAUSE FOR DISCIPLINE

(Purchased and/or Warehoused Dangerous Drugs

From Unlicensed Wholesalers Against Respondents)

80. Respondents are subject to disciplinary action under Code section 4301, subdivisions (j) and (o), for violating Business and Professions Code section 4169, subdivision (a)(1), because they purchased and/or warehoused drugs from unlicensed individuals or organizations, as described above in paragraphs 42 through 79.

SECOND CAUSE FOR DISCIPLINE

(Held or Offered for Sale Adulterated Drugs Against Respondents)

81. Respondents are subject to disciplinary action under Code section 4301, subdivisions (j) and (o), for violating Health and Safety Code sections 111250 and 111295 and Code section 4169, subdivision (a)(2), in that they held or offered for sale dangerous drugs that were adulterated within the meaning of Health and Safety Code section 111255, as described above, in paragraphs 42 through 79.

THIRD CAUSE FOR DISCIPLINE

(Sold or Delivered Adulterated Drugs Against Respondents)

82. Respondents are subject to disciplinary action under Code section 4301, subdivisions (j) and (o), for violating Health and Safety Code section 111295 and Code section 4169, subdivisions (a)(2), in that they sold or delivered dangerous drugs that were adulterated within the meaning of Health and Safety Code sections 11250 and/or 111255, as described above, in paragraphs 42 through 79.

FOURTH CAUSE FOR DISCIPLINE

(Violations of Drug Supply Chain Security Act Against Respondents)

83. Respondents are subject to disciplinary action under Code section 4301, subdivisions (j) and (o), for violating 21 United States Code sections 331, subdivision (t) and 360eee-1, subdivisions (d)(1)(A)(i), (d)(3) and(d)(4)(i), in that they failed to engage in transactions with authorized trading partners, accepted ownership of drugs without valid transaction information and transaction history (pedigrees) and failed to quarantine and promptly investigate suspect product, within the meaning of section 360eee, as described above, in paragraphs 42 through 79.

FIFTH CAUSE FOR DISCIPLINE

(Inappropriate Exercise of Education, Training or Experience Against Respondents Shekha Dashrath Patel, Shital Patel and Kinjal Ghanshyam Patel)

84. Respondents Shekha Dashrath Patel, Shital Patel and Kinjal Ghanshyam Patel are subject to disciplinary action under Code section 4301, subdivisions (j) and (o), for violating Business and Professions Code section 4306.5, subdivision (a), because they inappropriately exercised their education, training, or experience as a pharmacist when acquiring and dispensing dangerous drugs, as described above, in paragraphs 42 through 79.

SIXTH CAUSE FOR DISCIPLINE

(Unprofessional Conduct against All Respondents)

85. Respondents are subject to disciplinary action under Code section 4301 for unprofessional conduct because they engaged in the activities described above, in paragraphs 42 through 79.

DISCIPLINE CONSIDERATIONS

- 86. To determine the degree of discipline, if any, to be imposed on Respondents

 Advantage Health Care HIV & Compounding, Inc., dba Garden Grove Community Pharmacy and

 Shekha Dashrath Patel, Complainant alleges:
- a. On or about May 11, 2021, the Board issued Citation and Fine No. CI 2019 88503 to Respondent Advantage Health Care HIV & Compounding, Inc., dba Garden Grove Community Pharmacy for violating Business and Professions Code section 4169, subdivision (a), purchasing

thirty-six dangerous drugs from two unlicensed wholesalers and Health & Safety Code sections 111250 and 111295 for dispensing an adulterated drug. That Citation is now final.

- b. On May 11, 2021, the Board issued Citation No. CI 2020 91188 to Respondent Shekha Dashrath Patel for violating Business & Professions Code section 4169, subdivision (a), purchasing thirty-six dangerous drugs from two unlicensed wholesalers. That Citation is now final.
- 87. To determine the degree of discipline, if any, to be imposed on Respondents Advantage Health Care Services, dba Mission Plaza Pharmacy and Kinjal Ghanshyam Patel, Complainant alleges:
- a. On or about July 28, 2020, the Board issued Citation No. CI 2018 83685 to Respondent Advantage Health Services, dba Mission Plaza Pharmacy for violating California Code of Regulations, title 16, section 1793.7, subdivision (b)(e), failing to properly monitor pharmacy technician activities. That Citation is now final.
- b. That Citation is now final.

On or about October 29, 2020, the Board issued Citation and Fine and Order of Abatement No. CI 2020 89458 to Respondent Kanjal Ghanshyam Patel for violating Business & Professions Code section 4301, subdivision (f) and title 16, California Code of Regulations section 1761, subdivisions (a) and (b), for engaging in dishonest acts and dispensing controlled substances for unspecified patients or "office use." That Citation is now final.

PARTIES

- 1. Anne Sodergren (Complainant) brings this Accusation solely in her official capacity as the Executive Officer of the Board of Pharmacy, Department of Consumer Affairs (Board).
- 2. On or about December 19, 2017, the Board issued Pharmacy Permit Number PHY 55932 to AHCS Specialty Care, LLC, doing business as AHCS Specialty Care. Respondent Nevil Prakash Javeri was identified as a Member of AHCS Specialty Care, LLC and Shital J. Patel was identified as the Pharmacist-in-Charge from December 19, 2017 to December 3, 2020 (Respondent AHCS Specialty Care (PHY Permit Number 55932)). The Pharmacy License was cancelled on December 3, 2020.
- 3. On or about December 1, 2020, the Board issued Pharmacy Permit Number PHY 58059 to Innovative Healthcare Capital, LLC and AHCS Specialty Care, LLC, dba AHCS Specialty Care. Respondent Nevil Prakash Javeri was identified as a Member. Shital J. Patel was identified as the Pharmacist-in-Charge form December 1, 2020 to May 17, 2021 and Anil Kanwar was identified as the Pharmacist-in-Charge since May 17, 2021 (Respondent AHCS Specialty Care (Permit Number PHY 58059)). The Pharmacy Permit was in full force and effect at all times relevant to the charges brought herein and was canceled on November 9, 2023. Respondent AHCS Specialty Care (Permit Number 55932) are collectively referred to as Respondent AHCS Specialty Care.
- 4. On or about January 10, 2020, the Board of Pharmacy issued Pharmacist License Number RPH 81880 to Anil Kanwar (Respondent Anil Kanwar). The Pharmacist License was in full force and effect at all times relevant to the charges brought herein and will expire on April 30, 2025, unless renewed.

///

5. On or about June 29, 1998, the Board of Pharmacy issued Pharmacist License Number RPH 50125 to Shital J. Patel (Respondent Shital Patel). The Pharmacist License was in full force and effect at all times relevant to the charges brought herein and will expire on December 31, 2025, unless renewed.

JURISDICTION

- 6. This Accusation is brought before the Board of Pharmacy (Board), under the authority of the following laws. All section references are to the Business and Professions Code (Code) unless otherwise indicated.
- 7. Code section 4011 provides that the Board shall administer and enforce both the Pharmacy Law (Bus. & Prof. Code, § 4000 *et seq.*) and the Uniform Controlled Substances Act (Health & Safety Code, § 11000 *et seq.*).
- 8. Code section 4300, subdivision (a) provides that every license issued by the Board may be suspended or revoked.
 - 9. Code section 4300.1 states:

The expiration, cancellation, forfeiture, or suspension of a board-issued license by operation of law or by order or decision of the board or a court of law, the placement of a license on a retired status, or the voluntary surrender of a license by a licensee shall not deprive the board of jurisdiction to commence or proceed with any investigation of, or action or disciplinary proceeding against, the licensee or to render a decision suspending or revoking the license.

10. Code section 4307, subdivision (a) states:

Any person who has been denied a license or whose license has been revoked or is under suspension, or who has failed to renew his or her license while it was under suspension, or who has been a manager, administrator, owner member, officer, director, associate, or partner of any partnership, corporation, firm, or association whose application for a license has been denied or revoked, is under suspension or has been placed on probation, and while acting as the manger, administrator, owner, member, officer, director, associate, or partner had knowledge or knowingly participated in any conduct for which the license was denied, revoked, suspended, or placed on probation, shall be prohibited from serving as a manger, administrator, owner, member, officer, director, associate, or partner of a licensee as follows:

- (1) Where a probationary license is issued or where an existing license is placed on probation, this prohibition shall remain in effect for a period not to exceed five years.
- (2) Where the license is denied or revoked, the prohibition shall continue until the license is issued or reinstated.

A current inventory shall be kept by every 13 manufacturer, wholesaler, pharmacy, veterinary food-animal drug retailer, physician, dentist, podiatrist, veterinarian, laboratory, clinic, hospital, institution, or 14 establishment holding a currently valid and unrevoked certificate, license, permit, registration, or exemption under Division 2 (commencing with Section 1200) of the 15 Health and Safety Code or under Part 4 (commencing with Section 16000) of Division 9 of the Welfare and Institutions Code who maintains a stock of dangerous 16 drugs or dangerous devices. 17 (b) The owner, officer, and partner of any pharmacy, wholesaler, or veterinary food-animal drug retailer shall be jointly responsible, with the pharmacist-in-charge 18 or representative-in-charge, for maintaining the records and inventory described in this section. 19 20 21 Code section 4113, subdivision (c) states: 22 The pharmacist-in-charge shall be responsible for a pharmacy's compliance with all state and federal laws and regulations pertaining to the practice of pharmacy. 23

COST RECOVERY

18. Section 125.3 of the Code provides, in pertinent part, that the Board may request the administrative law judge to direct a licentiate found to have committed a violation or violations of the licensing act to pay a sum not to exceed the reasonable costs of the investigation and enforcement of the case.

DRUGS

- 19. <u>Abilify</u> is an expensive, antipsychotic drug and a dangerous drug as defined by Business and Professions Code section 4022.
- 20. <u>Invega</u> is an expensive, antipsychotic drug and a dangerous drug as defined by Business and Professions Code section 4022.
- 21. <u>Wellbutrin</u> is an expensive, antidepressant drug and a dangerous drug as defined by Business and Professions Code section 4022.

FACTUAL ALLEGATIONS

- 22. Respondent AHCS Specialty Care (Permit Number PHY 55932) was an open door, retail community pharmacy located in Garden Grove California, until its license was cancelled on December 1, 2020 due to a change in ownership. On December 1, 2020, Respondent AHCS Specialty Care (Pharmacy Permit Number PHY 58059) resumed pharmacy operations at the same location.
- 23. Respondent AHCS Specialty Care dispensed high value medications, including Abilify Maintenna and Ivega Sustenna which were administered for the treatment of psychological disorders to parolees, patients in state mental health clinics and people living on skid row throughout California.
- 24. From January 1, 2019 through January 18, 2022, Respondent AHCS Specialty Care purchased, transferred and warehoused Abilify Maintenna syringes and Ivega Sustenna syringes (approximate aggregate wholesale value of \$13,874,488.40), to and from Berry and Sweeney Pharmacy (Permit Number PHY 53432), AHCS Specialty Care Pharmacy #3 (Permit Number PHY 58145), Mission Plaza Pharmacy #2 (Permit Number PHY 58058), Mission Plaza Pharmacy (Permit Number PHY 51550) and/or AHCS Specialty Care Pharmacy #2 (Permit Number 57671).

- 25. Respondent purchased, transferred and warehoused the Abilify Maintenna syringes and Invega Sustenna syringes by taking advantage of manufacturer rebates offered to them. In total, Respondents transferred in approximately 3,273 units with a wholesale value of \$7,135,790.39 and transferred out approximately 2,585 units with a wholesale value of \$6,738,698.01 of either Ability Maintenna syringes/vials or Invega Sustenna syringes to the participating pharmacies. Respondents contended they could do so in order to alleviate a temporary drug shortage or to a pharmacy under common control/ownership, yet the drugs were not on short supply at the time and the pharmacies participating in the scheme were not under common control or ownership.
- 26. In fact, the operations of Respondent AHCS Specialty Pharmacy and the five other pharmacies identified in paragraph 24 were "left up to the discretion of [each] pharmacy's staff and [were] based on the specific needs of each operation."
- 27. Respondent AHCS Specialty Care did not maintain all records of the acquisition and disposition of dangerous drugs.
- 28. From January 1, 2019 through January 18, 2022, the following overages existed in Respondent AHCS Specialty Care's drug inventory: (1) 46 Abilify Maintenna ER 400mg syringes; (2) 68 Invega Sustenna 234mg/1.5ml syringes; and (3) 1,320 tablets of Wellbutrin XL 150mg.

FIRST CAUSE FOR DISCIPLINE

(Failure to Maintain Records of Acquisition and Disposition of Dangerous Drugs)

29. Respondents are subject to disciplinary action under Code sections 4301, subdivision (j) and (o), for violating Code sections 4081, subdivision (a) and 4169, subdivision (a)(5) and the owners are liable under Code section 4081, subdivision (b), because they did not maintain acquisition and disposition records of dangerous drugs open for inspection by authorized officers of the law and preserve them for at least three years from the date of making, as set forth in paragraphs 22 through 28 above, which are incorporated herein by reference.

SECOND CAUSE FOR DISCIPLINE

(Failure to Maintain Current Inventory of Dangerous Drugs)

30. Respondents are subject to disciplinary action under Code sections 4301, subdivisions (j) and (o), for violating Code section 4081, subdivision (a) and 4169, subdivision (a)(5) and title 16, California Code of Regulations, section 1718 and the owners are liable under Code section 4081, subdivision (b), in that they did not maintain a current inventory of drugs, as set forth in paragraphs 22 through 28 above, which are incorporated herein by reference.

THIRD CAUSE FOR DISCIPLINE

(Furnishing of Dangerous Drugs to Pharmacies)

31. Respondents are subject to disciplinary action under Code sections 4301, subdivisions (j) and (o), for violating Code section 4126.5, subdivision (a)(7), in that they furnished dangerous drugs to and purchased dangerous drugs from pharmacies not under common control as defined by Code section 4126.5, subdivision (e) and as set forth in paragraphs 22 through 28 above, which are incorporated herein by reference.

FOURTH CAUSE FOR DISCIPLINE

(Unprofessional Conduct)

32. Respondents are subject to disciplinary action under Code section 4301 for unprofessional conduct because they engaged in the activities described above in paragraphs 22 through 28, which are incorporated herein by reference.

DISCIPLINE CONSIDERATIONS

33. To determine the degree of discipline, if any, to be imposed on Respondent Innovative Healthcare Capital, LLC and AHCS Specialty Care, LLC, dba AHCS Specialty Care and Respondent Anil Kanwar, Complainant alleges on or about May 9, 2023, the Board issued Citation and Fine No. CI 2021 93376 to Respondent Innovative Healthcare Capital, LLC and AHCS Specialty Care, LLC, dba AHCS Specialty Care and Citation No. CI 2022 100195 to Respondent Anil Kanwar for making the unauthorized disclosure of medical information and obstructing a patient in obtaining his prescriptions which are violations of Civil Code section

56.10, subdivision (a), California Code of Regulations, title 16, section 1764, and Business and Professions Code section 733, subdivision (a). The Citations are now final.

OTHER MATTERS

- 34. Pursuant to Code section 4307, if discipline is imposed on Pharmacy Permit No. PHY 55932 issued to Respondent AHCS Specialty Care, LLC, dba AHCS Specialty Care, it shall be prohibited from serving as a manager, administrator, owner, member, officer, director, associate, or partner of a licensee for five years if Pharmacy Permit Number PHY 55932 is placed on probation or until the Pharmacy Permit is reinstated if it is revoked.
- 35. Pursuant to Code section 4307, if discipline is imposed on Pharmacy Permit No. PHY 58059 issued to Respondent Innovative Healthcare Capital, LLC and AHCS Specialty Care, LLC, dba AHCS Specialty Care, it shall be prohibited from serving as a manager, administrator, owner, member, officer, director, associate, or partner of a licensee for five years if Pharmacy Permit Number PHY 58059 is placed on probation or until the Pharmacy Permit is reinstated if it is revoked.
- 36. Pursuant to Code section 4307, if discipline is imposed on Pharmacy Permit No. PHY 55932 issued to Respondent AHCS Specialty Care, LLC, dba AHCS Specialty Care and/or Pharmacy Permit No. 58059 issued to Innovative Healthcare Capital, LLC and AHCS Specialty Care, LLC, dba AHCS Specialty Care while Respondent Shital J. Patel has been a manager, administrator, owner, member, officer or director and had knowledge of or knowingly participated in any conduct for which the licensees were disciplined, he shall be prohibited from serving as a manager, administrator, owner, member, officer, director, associate, or partner of a licensee for five years if the Pharmacy Permits are placed on probation or until the Pharmacy Permits are reinstated, if they are revoked.
- 37. Pursuant to Code section 4307, if discipline is imposed on Pharmacy Permit No. PHY 55932 issued to Respondent AHCS Specialty Care, LLC, dba AHCS Specialty Care and/or Pharmacy Permit No. 58059 issued to Innovative Healthcare Capital, LLC and AHCS Specialty Care, LLC, dba AHCS Specialty Care while Respondent Nevil Prakash Jhaveri has been a manager, administrator, owner, member, officer or director and had knowledge of or knowingly

participated in any conduct for which the licensees were disciplined, he shall be prohibited from serving as a manager, administrator, owner, member, officer, director, associate, or partner of a licensee for five years if the Pharmacy Permits are placed on probation or until the Pharmacy Permits are reinstated, if they are revoked.

- 38. Pursuant to Code section 4307, if discipline is imposed on Pharmacy Permit No. PHY 58059 issued to Respondent Innovative Healthcare Capital, LLC and AHCS Specialty Care, LLC, dba AHCS Specialty Care while Respondent Anil Kanwar has been a manager, administrator, owner, member, officer or director and had knowledge of or knowingly participated in any conduct for which the licensees were disciplined, he shall be prohibited from serving as a manager, administrator, owner, member, officer, director, associate, or partner of a licensee for five years if the Pharmacy Permit is placed on probation or until the Pharmacy Permit is reinstated, if it is revoked.
- 39. Pursuant to Code section 4307, if discipline is imposed on Pharmacist License No. RPH 50125 issued to Respondent Shital J. Patel, he shall be prohibited from serving as a manager, administrator, owner, member, officer, director, associate, or partner of a licensee for five years if the Pharmacist License is placed on probation or until the Pharmacist License is reinstated, if it is revoked.
- 40. Pursuant to Code section 4307, if discipline is imposed on Pharmacist License No. RPH 81880 issued to Respondent Anil Kanwar, he shall be prohibited from serving as a manager, administrator, owner, member, officer, director, associate, or partner of a licensee for five years if the Pharmacist License is placed on probation or until the Pharmacist License is reinstated, if it is revoked.

PRAYER

WHEREFORE, Complainant requests that a hearing be held on the matters herein alleged, and that following the hearing, the Board of Pharmacy issue a decision:
