**Authority for this Action**

Business and Professions Code Section 4316, subdivision (a), states, "the board, through its executive officer, is authorized to issue a cease-and-desist order for operating any facility under this chapter that requires licensure without obtaining that licensure or for practicing any activity under this chapter that requires licensure." Subdivision (b) of that section provides that, whenever the board issues a cease and desist order, the Board must immediately issue the facility a notice setting forth the acts or omissions with which it is charged, specifying the pertinent code section or sections and any regulations.

**Activities under this chapter that require licensure include those set forth in the following regulations:**

Business and Professions (BPC) section 4160, subdivision (a) states that a person shall not act as a wholesaler or third-party logistics provider of any dangerous drug or dangerous device unless he or she has obtained a license from the board. As related, BPC section 4160, subdivision (b) states that upon approval by the board and the payment of the required fee, the board shall issue a license to the applicant.

**Acts or Omissions Upon Which this Action is Based**

During a board investigation, it was discovered that A & C Medical Supplies was selling dangerous drugs in California without a wholesaler license in violation of BPC 4160, subdivision (a). This includes, but is not limited to, the following:

A & C Medical Supplies in their documentation states their address is 11030 Arrow Route, Unit 207, Rancho Cucamonga, CA 91730, and email: [acmedicalsupplyllc@outlook.com](mailto:acmedicalsupplyllc@outlook.com). However, this physical address was not occupied by A&C Medical Supplies on April 2, 2025 during an attempted inspection, and the property manager stated she had no knowledge of A&C Medical Supplies LLC.

Additionally, A & C Medical Supplies has advertised through an email communication for diabetic testing supplies and dangerous drugs which was emailed to a California pharmacy. The advertisements listed an email of [acmedicalsupplyllc@outlook.com](mailto:acmedicalsupplyllc@outlook.com).

## Order

On the basis of the foregoing, the Board, through its Executive Officer therefore ORDERS:  
Effective immediately, A & C Medical Supplies as an entity not licensed by the Board, shall cease and desist operating a facility under this chapter that requires licensure and practicing any activity under this chapter that requires licensure for distribution within California.

## Unlicensed Entity's Right to be Heard and Procedure

Pursuant to Business and Professions Code Section 4316, subdivision (c), within 15 days of receipt of this notice, A & C Medical Supplies may request a hearing before the president of the Board to contest this cease and desist order. Any contest of the cease and desist order will comply with the requirements of Section 11425.10 of the Government Code, a copy of which is enclosed. Chapter 5 of the Administrative Procedure Act (commencing at Government Code Section 11500) does not apply to this proceeding. The hearing will be held no later than five (5) days from the date the owner's request for a hearing is received by the Board. The president will render a written decision within five (5) days of the hearing. In the absence of the president of the Board, the vice president of the Board may conduct the hearing permitted by this subdivision. Review of the decision of the president of the Board may be sought by the owner or person in possession or control of the unlicensed entity pursuant to Section 1094.5 of the Code of Civil Procedure.
