4. **Discussion and consideration by the board to, pursuant to section 4062 of the Business and Professions Code, waive application of provisions of pharmacy law during the declared states of emergency in Lake, Napa, Amador, and Calaveras counties that will aid in the protection of public health or the provision of care.**
  - a. Delegation of authority to issue, or extend, waivers to the executive officer, a board member, or some combination thereof
  - b. Grant of a waiver in areas affected by the states of emergency, by proximity to state of emergency, with or without a request by the pharmacy, for example, to allow:
    - i. A hospital pharmacy the ability to provide medication to outpatients
    - ii. A pharmacy providing medication for seven days when there is no underlying prescription available
    - iii. With or without a medication container
    - iv. Any limitations to such waivers, for example, relating to controlled substances
