

Board Meeting Actions – April 26-27, 2022

The California State Board of Pharmacy took the following actions April 26-27, 2022:

- Reelected President Seung Oh, Vice President Maria D. Serpa, and Treasurer Jignesh “Jig” Patel to one-year terms, effective June 1, 2022.
- Approved minutes with modifications for typographical corrections for Board meetings January 27-28, 2022, and for March 16, 2022.
- Voted to modify authority delegated to the Board president to approve or extend Pharmacy Law waivers as appropriate based on current conditions through December 31, 2022, or until 90 days following the declared disaster, whichever is later.
- Received a report from the Organizational Development Committee.
- Reviewed a summary of work from the March 9, 2022, meeting of the Standard of Care Ad Hoc Committee.
- Reviewed a summary of work from the January 27, 2022, meeting of the Medication Error Reduction and Workforce Ad Hoc Committee.
- Reviewed a summary of work from the April 20, 2022, meeting of the Enforcement and Compounding Committee.
- Reviewed a summary of work from the April 26, 2022, meeting of the Communication and Public Education Committee.
- Voted to submit a letter commenting on proposed federal rules promulgated by the Food and Drug Administration regarding third-party logistics providers (3PLs) and wholesale distributors, and delegate to the Board president authority to work with staff and counsel on the letter that will include major concerns discussed as well as other matters consistent with policy discussions.
- Reviewed a summary of work from the April 19, 2022, Pharmacy Technician Summit held by the Licensing Committee.
- Received a report from the Executive Officer.
