a. Districts 6, 7, 8 Annual Meeting

NABP Districts 6, 7, and 8 Annual Meeting was convened October 20-22, 2024, in New Mexico. President Oh represented the Board. In addition to business meetings for each district, there were several presentations, including a Case Law Review, a panel discussion on "Perspectives on the Evolving Pharmacy Landscape", and Perspectives on Implementing Standard of Care Regulations. President Oh was reelected as the District Treasurer.

California is anticipated to host the District 6, 7, and 8 meeting in 2027.
