Subject: Executive Officer Report

a. Licensing Statistics

On a quarterly basis, the Licensing Committee and Board review licensing statistics and processing times. As the Licensing Committee did not meet this quarter, and to ensure the Board remains apprised of processing times and workload, provided below is summary information including processing times and licensing statistics for the first eight months of FY 2024/25 (July 1, 2024 – February 28, 2025). The detailed licensing statistics are provided in **Attachment 1**.

During the timeframe, the Board has received 9,365 initial applications, including:

- 1,121 intern pharmacists
- 1,363 pharmacist exam applications (437 new, 926 retake)
- 103 advanced practice pharmacists
- 3,880 pharmacy technicians
- 644 community pharmacy license applications (344 chain, 300 nonchain)
- 59 sterile compounding pharmacy license applications (48 LSC, 11 NSC, 0 SCP)
- 95 nonresident pharmacy license applications
- 9 hospital pharmacy license applications

During the timeframe, the Board has received 6 requests for temporary individual applications (Military Spouses/Partners), including:

- 6 temporary pharmacy technicians

During the timeframe, the Board has received 794 requests for temporary site license applications, including:

- 600 community pharmacy license applications
- 47 sterile compounding pharmacy license applications
- 64 nonresident pharmacy license applications
- 9 hospital pharmacy license applications

During the timeframe, the Board has issued 6,821 individual licenses, including:

- 1,107 intern pharmacists
- 1,200 pharmacists
- 94 advanced practice pharmacists

- 4,023 pharmacy technicians

During the timeframe, the Board has issued 6 temporary individual applications (Military Spouses/Partners), including:

- 6 temporary pharmacy technicians

During the timeframe, the Board has issued 405 site licenses without temporary license requests, including:

- 91 automated drug delivery systems (89 AUD, 2 APD)
- 62 community pharmacies
- 1 hospital pharmacy

During the timeframe, the Board has issued 695 temporary site licenses, including:

- 554 community pharmacies
- 13 hospital pharmacies

b. Biannual Report of the California Practice Standards and Jurisprudence Examination for Pharmacists (CPJE) and the North American Pharmacist Licensure Examination (NAPLEX)

Generally, twice a year the Board publishes a report on the pass rates for the CPJE and NAPLEX exams. Data including aggregate information for examinations administered between October 1, 2024, and March 31, 2025, inclusive, will be available before the Board meeting.

c. Online Renewal Payments

Although online renewal processes have been available for a number of the Board's licensing categories, last year, the Board began its transition to renewal postcards with the link to the Board's online renewal system, in lieu of renewal applications, for many of its individual license types. This approach is consistent with several programs within DCA. The Board has used its subscriber alert system as the primary communication vehicle for licensees about the change. In September 2024, a banner was added to the top of the Board's homepage to make it easily accessible for licensees and an article was written about the renewal process in the December 2024 issue of *The Script*.

Although the transition has not been without some challenges, in Quarter 2 of the Fiscal Year (January 1, 2025 – March 31, 2025), 94.3% of pharmacists and pharmacy technicians renewed their licenses online.

As previously reported, challenges stemming from a transition to a new payment vendor began in November 2024. Regrettably, these challenges continue. The issue is limited to a small number of online transactions.

d. CURES Fee Increase

As previously reported under provisions of SB 164 (Committee on Budgets, Chapter 41, Statutes of 2024), Board licensees will incur a higher CURES fee from \$9 annually to \$15 annually. These new fees impact licenses expiring on or after April 1, 2025. The Board has released information reminding licensees of these increases. An example of the message released is provided below.

e. Medication Error Reporting

Relevant Law: Business and Professions Code (BPC) Section 4113.1 establishes requirements for a community pharmacy to report, either directly or through a designated third party, medications errors to an entity approved by the Board.

Background: As part of its implementation activities related to Assembly Bill 1286 (Haney, Chapter 470, Statutes of 2023), the Board was required to approve an entity to receive and review medication error reports consistent with the provisions of law. Following the state contracting process, as part of the Board's September 12, 2024 meeting, the Board approved ISMP as the entity to receive and review the reports. The contract was signed and approved on January 30, 2025.

Recent Update: Staff have been working with ISMP on implementation activities. The Board anticipates notifying licensees via subscriber alerts in mid-April 2025 of their legal responsibility under BPC section 4113.1 and that ISMP is the named vendor for collecting reports and billing. Further, the Board anticipates ISMP will be sending a postcard to licensees around the same time with information regarding medication error reporting as the Board's approved entity.
